PCE Standard Accessory, Component, Cylinder, and Engine Repair Warranty and Disclaimer

Each repaired or overhauled accessory, component, or cylinder, and any repaired engine shipped from Pacific Continental Engines Inc is warranted as follows:

For a period of six (6) months or (250) hours of operation, whichever occurs first, from the date of installation or (10) ten days after shipment date, Pacific Continental Engines Inc (PCE) will at its option repair or replace on an exchange basis any accessory, component, or cylinder supplied by PCE which within the applicable six (6) month or (250) hour period is returned to PCE and which upon examination is found to the satisfaction of PCE to be defective in material or workmanship.

Repair or replacement of any accessory, component, or cylinder under this warranty will not extend the period of warranty coverage set forth above. PCE reserves the right at its option to replace any defective accessory, component, cylinder, or repaired engine with another accessory, component, cylinder, or repaired engine with equal time in service.

PCE will not assume any responsibility for any labor or transportation costs in connection with the repair or replacement of any accessory, component, cylinder, or repaired engine under this warranty.

This warranty applies only to accessories, components, cylinders, and repaired engines, supplied by PCE. Nothing contained herein should be construed as a warranty by PCE of any accessory, component, cylinder, or repaired engine not previously repaired, overhauled, or supplied by PCE. PCE accepts no responsibility for the failure of any accessory, component, cylinder, or repaired engine which it does not supply or damage resulting from such failure.

This warranty applies only to accessories, components, cylinders, and repaired engines which have been installed, inspected, or maintained in accordance with the instructions for continued airworthiness, including compliance with all applicable service bulletins issued by the original engine manufacturer (OEM), the aircraft manufacturer or any accessory or component manufacturer. Performance of recommended inspections and maintenance must be documented by appropriate logbook entries and a copy of the logbook must accompany any accessory, component, cylinder, or repaired engine being returned for warranty consideration.

This warranty does not apply to any accessory, component, cylinder, or repaired engine supplied by PCE and installed which (1) has been subject to misuse, neglect, improper storage or accident; (2) has been installed, repaired, maintained or altered in any way that in the judgment of PCE has adversely affected the condition of; (3) has been operated inconsistent with PCE, OEM, aircraft manufacturer recommendations and limitations (such as, but not limited to engine RPM, temperature, manifold pressure, fuel flow and proper system adjustment) or (4) has been changed from its original FAA certificated configuration.

PCE will not be responsible for repair or replacement of any accessory, component, cylinder, or repaired engine damaged or worn because of corrosion, pre-ignition/detonation, operation with noncalibrated engine gauges, improper fuel system adjustment, non-FAA approved fuel and oil

grades or additives or installation of parts, components or accessories that alter original type design.

THE SOLE AND EXCLUSIVE REMEDY UNDER THIS WARRANTY IS LIMITED TO REPAIR OR REPLACEMENT AS SPECIFIED ELSEWHERE IN THIS DOCUMENT. THERE ARE NO OTHER WARRANTIES EXPRESSED OR IMPLIED. SPECIFICALLY, BUT WITHOUT LIMITATION, THERE ARE NO IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT WILL TCM BE RESPONSIBLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF ANY DEFECT IN ANY PART, COMPONENT OR ACCESSORY, ARISING OUT OF THE FAILURE OF ANY PART, COMPONENT, OR ACCESSORY TO OPERATE PROPERLY OR ARISING OUT OF ANY BREACH OF THE WARRANTY MADE HEREIN. No person is authorized to give any other warranty or to assume any additional obligation or liability on behalf of PCE.
